#### DISMANTLE NATIONAL LIBERAL ORDER

1980s

Roundtable joined to political power with Reagan Repeal Deal: unions, regulation, public sector, social welfare Public Education placing "nation at risk" (\$600b market) Rejection of policies associated with John M. Keynes.

Re-Concentrate Wealth via Tax cuts; shift burden. (net worth triples) Restructure corporations: National to Transnational form (1/4;50%) New production system: Fordist fixed to flexible, computer controlled US service sector dominance: Need to Export

Collapse of USSR and previous opening of China in mid-1970s End of Cold War: 1989. – The Globe is open to Transnational capital

1990

George Bush address to Congress. 9/11/90 Iraq's invasion of Kuwait : August 2, 1990 Five UN Security Council resolutions to withdraw Fifth objective: a new world order: law over jungle Shared responsibility and strong respect weak.

**BEYOND THE NATION-STATE: NEW FORMS OF CONTROL** 1990s

Foreign policy is domestic policy overseas: lock in 80s victories Respond to existence of transnational corporations and production

Enterprise of the Americas (BUSH); EU in West; Japan in East Model (NAFTA) signed by Bush in 1993/Clinton in 1994 (fast track) FTAA in 1995 – all Latin American countries by 2005 World Trade Organization approved by US Congress (1995) World Economic Forum (as global governance in Davos)

## GLOBAL NEO-LIBERAL ORDER AS ENBEDDED IN "TRADE AGREEMENTS"

Import Substitution to Export Led (National Treatment/MFN/Bans) Remove barriers to Transnational Capital Movement (Performance) Investment Protection (Chapter 11) Tantamount to expropriation Extraction of publicly-held social wealth: privatization Service Expansion: finances, insurance, professional services (GATS) Arbitral System replaces national Legislative system: dispute panels.

Zapatista Rebellion in Chiapas (1994) – Civil Society mobilization Fast Track Defeat (1996) and MAI exposure (1998) – cities WTO Ministerial in Seattle: This is What Democracy Looks Like (99) Exposure of inequities in WTO Bargain. Not resolved. Cancun/HK World Social Forum (WEF) : Brazil (01/02), India, Venezuela (06) L.A. Electoral Victories: Brazil, Argentina, Venezuela, Bolivia. Defeat of FTAA at Summit of Americas (Argentina, November 2005) US Social Forum in Atlanta, Summer 2007.
