UNSTOPPABLE TECHNOLOGICAL REVOLUTION (LEXUS/OLIVE TREE). THOMAS FRIEDMAN

ON-GOING IMPERIAL PROCESS OF THE NORTH CONQUERING SOUTH (JAMES PETRAS)

EXPANSION OF US CAPITAL INTO FORMER USSR

EXPANSION OF FINANICIAL SPECULATION DUE TO A LESS PROFITABLE GOODS PRODUCTION SYSTEM (AHRIGI)

MILITARY EXPANSION OF A DYING HEGEMON (PRODUCTION, FINANCIAL SPECULATION TO MILITARIZE CONTROL EFFORT)

A SYSTEM JUMP FROM POST WWII INTERNATIONAL INSTITUTIONS DESIGNED TO BREAK DOWN NATIONAL BOUNDARIES TO A SELF SUSTAINING GLOBAL SYSTEM NO LONGER TIED TO NATIONAL CAPITAL. (TEEPLE). A JUMP MADE POSSIBLE BY TECH. INNOVATION

MY DEFINITION -

GLOBALIZATION IS A REFLECTION OF U.S. DOMESTIC POLICY
DEVELOPED IN THE 80s and EXPORTED IN THE 90S

THAT THIS IS A CONTESTED DOMESTIC POLICY. IT IS
PROPOSED AND FOUGHT OVER BY CONTENDING FORCES.

THAT WHAT EXPLAINS THE SHAPE OF GLOBALIZATION IS
BASED ON THE STRUGGLE BETWEEN THESE CONTENDING

FORCES: MARKET AND COMMUNITY VALUE SYSTEMS.

OFTEN PLAYED OUT IN NON-PARLIAMENTARY AREANAS

OF STRUGGLE.
